Sports Parent Consent and Agreement to COVID-19 Procedures

The health and safety of our members, staff, and their families is the Club's first priority. To promote the safety and well-being of all who participate in Club sports, we must follow certain precautions and procedures directed by the CDC, state, and county health. Please read through each statement and initial next to each statement indicating you understand and agree to the mandatory procedures.

_____ 1. I agree that my child(ren) will use hand sanitizer upon arrival to the playing field, and will not touch any equipment until this has happened.

_____ 2. I agree that at half time, or during any other required break, my child(ren) will use hand sanitizer.

_____ 3. I agree to keep my child(ren) home if they or anyone in the household exhibits symptoms related to COVID-19.

_____ 4. I understand that I am responsible for providing my child(ren) a mask if I desire them to wear one while participating in Club sports.

_____ 5. I understand that Club staff are not responsible for ensuring a mask is worn correctly by my child(ren).

_____ 6. I understand that parents/guardians/spectators will be asked to social distance while attending practices and games, and they will refrain from using the same sanitized equipment that players are using. (Example – no playing catch).

_____ 7. I agree to provide an updated and current daytime phone number and an updated and valid emergency contact phone number, to allow for health department tracing needs if required.

_____ 8. I agree to comply with all procedures, expectations, and directives from all Club sports staff that is set forth at my specific playing field and that I will ensure my child(ren) will do the same.

_____ 9. For sanitation and safety concerns, I will not bring team snacks/drinks to be handed out before or after any practices or games.

Dear Parents and Guardians of Sports Participants:

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The health and safety of our members, staff, and their families is the Boys & Girls Clubs of Central Wyoming’s first priority. To promote the safety and well-being of all who participate in Club sports, we have put in place preventative measures to reduce the spread of COVID-19; however, the Club **cannot guarantee** that you or your child(ren) will not become infected with COVID-19. Further, **participating in Club sports could increase** your and your child(ren)’s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending and participating in Club sports and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 while attending or participating in Club sports may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Club employees, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)’s attendance at the Club or participation in Club programming and or sports (“Claims”). On my behalf, and on behalf of my child(ren), I hereby release, covenant not to sue, discharge, and hold harmless the Club, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I specifically agree that the Club has no liability for any Claim or legal action that may arise based upon my or my child(ren)’s participation in Club programming and or sports and will indemnify, pay for the defense, including attorney’s fees, and hold the Club harmless from any such claims or legal actions should they arise.

I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Club, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Club program or sports.
